Dear Potential Contestant:

On behalf of the Miss Rodeo Florida Association, I would first like to congratulate you on taking the first step towards achieving your goal of becoming Miss Rodeo Florida (MRF) – ages 21-26, Miss Teen Rodeo Florida (MTRF) ages 16-19, MRF Princess ages 12-15 , and MRF Sweetheart ages 7-11. This is the best hands-on experience for these younger divisions to shadow our older contestants and learn how to become Rodeo Queens.

I would like to share with you some of our expectations and obligations you must agree to, should you be selected Miss Rodeo Florida or Miss Teen Rodeo Florida.

First, you must understand, this is a contractual obligation between you and our Association. The contract you will be required to sign will spell out your duties and responsibilities. It is imperative that you read it and understand it, prior to the pageant. The contract can be found on our website. For those queens that are 18 years old, please remember this job and contract are yours, not your parents. The association will be dealing strictly with you on all business matters.

You and your family must also understand that even though our organization helps you with some costs in the upcoming year, there is still a serious financial commitment to you and your family. **Coronation** - Your main fundraiser for your reign is your responsibility to arrange and produce within the first couple of months after your reign begins. This function is vital to the financial wellbeing of your year. The money earned will be used to begin building your wardrobe and to pay for your upcoming travels. It is also your responsibility to find sponsors to assist you with these areas. The more you raise, the more you will travel. I cannot stress how important it will be that you have access to sponsors and help within your community all year long. It is a very long and tiring year (but fun too!) and you will need to seek the support and advice from many.

This brings me to the issue of transportation. It is your responsibility to have reliable sound transportation or means to secure a vehicle sponsor for your year. You do not need to have a pickup and trailer; a small economical car is perfectly acceptable. Most Florida rodeo's will assist you with getting a horse for their event, you may have to ask around at the event so plan to be there early. But remember it is your responsibility to have a horse available and transported to events that will require one (like parades).

For Miss Rodeo Florida 2023: Your first trip that we will help you arrange is to the Miss Rodeo America Pageant in Las Vegas, NV, the first week in December 2022. It is required that you attend the entire pageant. That means you will need to provide airfare, tickets to the events, and a hotel room for yourself. Many girls have gone out and secured a sponsor for this event. Your

parents are welcome to attend with you, at their own expense, or you can travel with members of the MRF Association, and we can also assist you in finding a roommate for the pageant.

Being Miss Rodeo Florida or Miss Teen Rodeo Florida is a fabulous experience, a wonderful opportunity, and will be a lasting memory for you. It is a job; and you will be expected to be present at all appearances, be on time, and dressed for each appearance and to continue to smile, even when you are tired. Miss Rodeo Florida 2023 is expected to begin preparations (e.g. studying, fitness plan, riding, modeling training, and wardrobe design) for the Miss Rodeo America 2024 pageant at the beginning of her reign. The National Director will have a ninety day review with her in April 2023 and will provide her a written plan on areas that need improvement. If after 45 days, those corrections are not made, the Executive Board reserves the right to award the first runner-up the title of Miss Rodeo Florida 2023. If the winner forfeits her crown, either voluntarily or by the board, she will be responsible for paying back the costs of any awards or sponsorship that she may have received during her reign and returning all items associated with her title and crown.

College - The winner of Miss Rodeo Florida 2023 may be asked to take the Fall Semester of the 2023 year off from school in order to prepare for the Miss Rodeo America 2024 competition.

Please be sure to read the rulebook and all packet materials carefully and thoroughly. I am sure you will find the answers for many of your questions within this packet. Take your time filling out your application. If you have any questions, please feel free to give me a call at the above number.

When you return your application, be sure to include:

- 1) Entry fee (\$250- MRF/\$200- MTRF) (\$150 - MRF Princess/MRF Sweetheart)
- 2) Pageant Application Agreement
- 3) Copy of Birth Certificate
- 4) Hold Harmless Agreement (completed and notarized)
- 5) Photo Release form / Media Release form / Medical Release form
- 6) Ad Sales Money, Ad Copy
- 7) (1)-color, 8x10 and (4)- color 5x7's, Indoor photo by Professional Photographer, All same pose, Solid Background, head/shoulder shot, wearing Western Wear to include long sleeve shirt, Western Hat. No outside photos, Tiaras or crowns may be worn.
- 8) It is highly recommended to also return the completed "Parents and Guests Ticket Reservation Form" at this time as well.

A checklist is enclosed in your application to make sure you have everything completed.

The **deadline for applications** to be postmarked is **July 31, 2022**. It is PERFECTLY acceptable, and encouraged to send your application in earlier – that way we can make sure you have everything correct before the deadline.

Raffles/Ad Sales - All contestants of the Miss Rodeo Florida / Miss Teen Rodeo Florida / Miss Rodeo Florida Princess and Miss Rodeo Florida Sweetheart will be required to sell at least 20 Raffle Tickets @ \$5.00 apiece, for a chance to win a Yeti Cooler filled with goodies and Ads for the Official Pageant Program Book. You will be sent 50 raffle tickets but you can always request more tickets. You will also be required to sell at least \$150.00 worth of ads for the Official Pageant Program Book. (Each full-page ad is \$100.00). For every ad amount you sell after your initial mandatory \$150.00 you will receive 10% back. This is a great way to earn back your contestant entry fees for the pageant. (Please note that ads and raffle tickets are mandatory but do not count toward the contestants final score). The ads for the pageant program book must be turned in with your application and the sold raffle tickets and money must be turned in at Orientation at the Miss Rodeo Florida Pageant.

Auction – MRF/MTRF contestants are required to bring an item for the live auction that will take place during the fashion show portion of the pageant. You will not be judged on the item, but on your presentation/sell of the item. Please be prepared to describe the item and reflect your personality when presenting the item at the auction. All Princess and Sweetheart contestants are asked to bring an item for the silent auction.

Clinic – Silver Spurs Club House – Kenansville, on August 14, 2022 from 9am – 4pm is a **Mandatory** MRF Clinic where we will go over everything about the pageant and make sure everyone is on the same page and pageant ready.

I know some of this may sound a bit overwhelming, but don't let it deter you from your dreams. It is possible to raise enough money to cover your entire year, without having to spend any personal money. If you are dedicated and determined, it can be done.

Again, congratulations on taking the first step towards achieving your goal.
